In connection therewith, the Board will consider resolutions authorizing the issuance of such Bonds, approving the execution and delivery of the Indentures and all other related agreements, amendments, certificates, filings or other documentation necessary to complete the Bond transaction, including a Bond Purchase Agreement for the Series 2016A Bonds and Series 2016B Bonds; approving, ratifying and confirming the execution of certain related documents; making determinations and findings as to other matters related to such Bond transaction; authorizing incidental action; and repealing prior inconsistent actions.
